Vehicle Judging Definitions:

Stock: A stock vehicle should look just like it did when it sat on showroom floor. All parts and colors should be correct for the year and model. Dealer and aftermarket accessories are allowed if they are from the same time periods as the car.

Modified: A modified class vehicle utilizes a combination of a stock and/or custom paint, upholstery and engine changes. The only body modifications allowed are de-chroming and/or one-piece windows. All other modifications must be bolt-on items. *Any modifications which alter the lines of the body from stock – chopped top, wider fenders, frenched lights, sunken antenna, etc – are not allowed in this class.*

Radical Customs: Any type of modifications is allowed. *Must Be VW Powered!*

Under Construction: Must be obviously unfinished and un-drivable

Driver / Primary Transportation: Vehicles which are driven 12 months a year in any and all kinds of weather. This is your daily driver. *Must be driven to the show and show evidence of wear. Minimum of 10,000 miles since new or restoration.*

Please Note: These guidelines will be strictly enforced to allow fair competition. Any questions please ask. Decisions of the Judges will be Final.
